

Application for a Wells Cathedral Parish Pass

Wells Cathedral Parish Passes are issued to parishioners listed on a Parish's Electoral Roll or Cathedral Community Roll, living in the Diocese of Bath and Wells. Each parishioner needs to apply for an individual pass. If you are applying for more than one pass, you will need to provide proof of address for each named individual.

If you would like to apply for a pass, please complete sections I and 2 below, and ensure you have read the terms and conditions outlined in section 4. Then, take your form to the Welcome Desk in Wells Cathedral **with a valid proof of address** (e.g., passport, driving license, or utility bill). Your pass will be valid for the duration of the electoral roll period and allows you access during visitor hours to the ground floor of the Cathedral.

Section 4: Terms and Conditions

- 1. The Parish Pass entitles the authorised cardholder to free entry to Wells Cathedral during standard visitor opening hours. These hours are subject to change, and the Cathedral retains the right to alter opening times and access restrictions as required.
- 2. The Parish Pass is valid only for use by the named cardholder. It is non-transferable and may not be used by family members or any other individuals. Proof of identity may be required.
- 3. Upon each entry to the Cathedral during visitor opening hours, the Parish Pass must be presented and scanned at the Welcome Desk.
- 4. The Parish Pass does not grant entry to paid exhibitions, guided tours, or concerts where an additional charge applies. However, it may be used to confirm eligibility for discounted entry when explicitly stated as part of a promotion. The card is valid for entrance to free family holiday activities.
- 5. The expiry date of the Parish Pass is determined by the end of the current parish electoral roll period.
- 6. Wells Cathedral reserves the right to amend or withdraw the Parish Pass scheme at any time without notice
- 7. Acceptance and use of a Parish Pass indicates acceptance of these terms and conditions.
- 8. Any breach of these terms and conditions will render the card invalid and may result in admittance being denied and the card being confiscated at the point of entry.
- 9. The Cathedral reserves the right to refuse admission or remove from the premises any person whose behaviour may compromise the safety or wellbeing of others, interfere with the use or enjoyment of the Cathedral as a place of worship, devotion, or pilgrimage, or cause damage to the fabric or contents of the buildings.
